The Village provides the Single-Family Loan Rehabilitation Loan program and Home Weatherization Grant program to assist qualifying residents to correct code violations, health or safety hazards, deficiencies in the home, and to complete weatherization improvements. Funds are provided through the Community Development Block Grant (CDBG) program, allocated to the village by the U.S. Department of Housing and Urban Development (HUD). Homeowners may qualify for repairs for up to \$25,000 in a 0% interest grant.

<u>Eligible improvements include</u> basic structural repairs, roof, doors, windows, electrical, plumbing, heating, and weatherization. Energy star materials are used where applicable. Households must meet income and other eligibility guidelines. <u>Suitable properties</u>: Single family homes, condominiums, townhomes. All jobs are completed by licensed and insured contractors.
